NOTIFICATION

NO. AHBP-PPIU/2013/3202 With the prior approval of the Competent Authority, The Government of Balochistan, Secondary Education Department is pleased to regularize the services of 5000(Five Thousand) Package Teachers appointed in B-14 and B-16 respectively under Aghaz- e-Haqooq -e- Balochistan (AHBP) with immediate effect on the following conditions:

- They are regularized on their respective grades with immediate effect with a changed nomenclature as JET (B-14), JAT (B-14), SST (B-16), and SAT (B-16) of their respective grades.
- They shall produce an affidavit (of worth Rs.100 duly attested by a Notary Public) regarding not claiming any back benefit of service, seniority and pay.
- 3. They will have to produce an affidavit (of worth Rs.100 duly attested by a Notary Public) for not being a regular student, dual employment or fake/bogus documents.
- Consequent upon their regularization, their all documents and residential status shall be re-verified by the Director schools.
- On the basis of the individual re- verification by the Director Schools and production
 of a certificate to this effect, the Secondary Education Department will issue
 individual regularization orders.
- After having completed the re-verification and production of certificate to this effect
 by the Director Schools, the regularized teachers shall be allowed to draw their
 salaries.
- 7. Consequent upon their regularization, all the Package Teachers/ Assistant Lecturers will have to report to the Director (Schools) immediately for their rationalization /reposting as per needs and requirements of the Schools of the area concerned.
- They shall not be entitled for benefits of the up- gradations of SSTs from BS-16 to BS-17 rather fulfillment of the required qualifications, they shall be entitled for the upgradation of B-17.
- The regularized teachers will have to complete their prescribed professional qualifications within 03(three years) failing which their services stand terminated without any notice to this effect.
